- a. By-Laws Changes and Issues (Tim Kelly)
 - i. Committee is meeting and has identified options—Tim amended by-law to be in line with State of Alaska law. President is now a voting member of the board.
 - ii. Proposed Updated By-Laws Acceptance/Board Vote—Barb motioned to accept amended By-Laws, Havoc seconded motion *approved by board*

- c. ABATE Raffle with STNMC (Ed)via telephone
 - i. Permit use agreement from STNMC
 - ii. Ed recommends that we have 750 tickets printed in books of 10 each. Tickets to sell for \$10 each—motion to accept above recommendation RC, seconded by Havoc---*approved by board*
 - Based on recent STNMC experience, I would expect that we would sell between 500 to 600 tickets. That should result in proceeds of \$5,000 to \$6,000 dollars.
 - Being conservative for the prize patrol, let us assume \$5,000. That is about what STNMC did with their last raffle. They had prizes of \$1,000 \$750 and \$500. \$2,250 total.
 - That might be part of why they only did \$5,000 in sales.
 - I recommend that we give away ½ of our estimated income; or \$2,500 of the \$5000. A bit more than STNMC.
 - I like the idea of a \$1,500 first prize, \$600 second prize and \$400 third prize. I think people only take note of the first prize amount anyway. Having a second and third place prize just adds more for chances for someone to win.

Agreed to by unanimous consent

- Or we could have a Grand Prize of \$2,500 and nothing else
- iii. Whatever the total prizes come to, we are on the hook for that entire amount even if we never sell one ticket.
- iv. This is a board decision. They need to decide how many tickets to print (I recommend 750), how much per ticket (I recommend \$10 each), and the number and amounts of prizes.
- v. Once decided, raffle tickets can be printed
- vi. Ed is due back on the 7th and can get the printing lined up soon after

- vii. As for selling tickets, I think having a booth at the downtown bazaar will help immensely. Considering that I may not be able to ride for weeks or months because of my upcoming foot surgery, I see no reason that I cannot attend the booth much of the time. I will need another person to assist with the canopy set up and take down and to cover the table during short breaks.
