

2020 Information for Food Vendors

Dear Food Vendor,

You are receiving this information because you participated in a previous Gathering at the Bike Blessing, or you expressed an interest in participating in the 2020 Gathering at the Bike Blessing.

Event Details

Date: Saturday, May 2ND from 9 am to 3 pm, but setup begins at 7:30 am. You are encouraged to come early, especially if you have a food truck or other large vehicle because access and parking will become difficult once motorcycles start arriving.

Location: Delaney Park Strip, Memorial Block between 9th and 10th Avenues and between I Street and K Street.

Booth Fee: Food Vendors - \$300. If you require two spaces, please contact us as soon as possible. Extra space, if available, may require an additional fee.

Where to unload: Drive your vehicle to 10th Ave and unload your belongings. A team of JROTC youths will stand by to watch for your things while you park your vehicle, and they can also help carry your stuff to your booth location.

Where to park: You will be able to park on the East side of I Street on 10th Ave.

Commercial booths and Hot Dog Cart locations will be on the lawn along with motorcycle clubs and not-for-profits.

Food trucks and carts will park on the lawn if the weather is good. Any vehicle parking on the lawn must have a drip pan. If the weather is bad, food trucks will park on 9th Ave. Trucks pulling trailers must drop the trailer and park elsewhere or pay for two spaces.

Other requirements for food trucks/vendors:

Municipal Permits: All food trucks and food vendors are required to have a permit from the Municipality of Anchorage. Please submit a copy of your Municipal permit and a picture of your food truck, or cart along with the application.

Event Insurance: You must provide a Certificate of Insurance for at least \$1,000,000 General Liability at the time you submit your application. You must include ABATE of Alaska as an additional insured.

Fire Extinguishers: All food vendors will be required to have an appropriate fire extinguisher with current tagging at their booth location. That is probably a Type K extinguisher for food trucks.

LPG Tanks: Vendors using LPG tanks with 10' or longer hoses are required to have tanks protected from pedestrian traffic, and the tanks must be securely anchored from an accidental knockdown.

Generators: Vendors with generators will be required to position them so that there is no fuel or flammable material in the area. Generators will be securely positioned so that pedestrian traffic will not get hurt/burned from any hot parts of the generator, such as the muffler. Any extra gas supplies will be stored at least 20' away from the generator.

Tents & Canopies: There will be no enclosed tents at the event; only small canopies that are open on at least one side. Retail and Food booths are 15x20; nonprofit booths are 15x15. Dealer canopies are maybe a little larger.

MPORTANT: You must submit a complete application, including the Certificate of Insurance and MOA Permit, with payment no later than the end of the ABATE General Membership Meeting at Guido's Pizza on April 16th, 7-9 pm. But don't wait until the last minute as the number of vendors participating will be limited.

Applications submitted between April 17th and 5:00 pm April 23rd will be charged an additional \$100 fee. No applications will be accepted after April 23rd.
